Revitalizing the Federal Courts

- In 2013, former Democratic Majority Leader Reid ended the filibuster on judicial nomination votes.
- Supreme Court Justices: Neil Gorsuch and Brett Kavanaugh
- Senate confirmed 187 federal judges to the federal bench in the last three years.
- Including 50 judges to the federal circuit court of appeals
 - In 2017, when President Trump took office, Democratic appointees made up the majority on nine of the 13 circuit courts.
 - In 2020, President Trump's appointments flipped three circuit courts:
 - 2nd (NY, VT, CT)
 - 3rd (DE, NJ, PA)
 - 11th (FL, GA, AL)
 - In total, seven circuits have Republican majority appointees.





Senate Balance of Power


Trump's re-election outlook and each party's ability to field strong candidates are key

Senate 2020 Forecast



Big Picture on 2020 House Races

All 435 House seats are up in 2020

- Democrats are defending their majority after a net gain of 40 seats in 2018 election
- Republicans would need to net around 18 seats to flip the chamber
- Some of the most closely watched races will be districts won by the other party's 2016 presidential candidate

- Progressive Democrats are aiming to repeat Alexandria Ocasio-Cortez's upset win <u>by mounting liberal primary bids</u> to oust long-time incumbents
 - New York (June 23): Foreign Affairs Committee Chairman Eliot Engel, Judiciary Committee Chairman Jerry Nadler, Oversight and Reform Committee Chairwoman Carolyn Maloney, and Yvette Clarke
 - Massachusetts (Sept. 1): Ways and Means Committee Chairman Richard Neal
 - Ocasio-Cortez opposed by Michelle Caruso-Cabrera, a former broadcast journalist with donors including Goldman Sachs CEO David Solomon
 - Rep. David Scott (D-Ga.) was unexpectedly pulled into an Aug. 11 runoff in the safely Democratic 13th District near Atlanta


Several Republicans facing challenges, too:

- Kentucky's Thomas Massie, a libertarian-leaning maverick who irked Trump and colleagues by seeking a roll-call vote on a coronavirus relief package in March, is opposed (June 23) by Todd McMurtry, a lawyer
- With the encouragement of some Kansas Republican officials, state Treasurer Jake LaTurner is opposing (Aug. 4) first-term Rep. Steve Watkins in the primary in the Topeka-area 2nd District

If House seats were allotted using the 2019 population estimates, Texas would gain two seats. ٠





Population Shift Helps South and Southwest

- New state census totals show population continuing to shift from the North and Midwest to the South and Southwest
- The results of the 2020 census will determine the new distribution of House seats and Electoral College votes by December 2020. The first elections likely to be affected by the seat changes will be in 2021. Most states will redraw congressional and legislative districts in time for 2022 votes.
- The latest data reflect sweeping changes across the U.S. since the start of the decade:
 - Americans are getting older and having fewer babies;
 - Immigration is slowing, and the rate at which people move between states is at its lowest level in decades; and
 - Those who do uproot are often leaving the Northeast and Midwest for warmer places in the Sunbelt and pockets of the West because of their favorable weather, strong job growth, cheaper housing and, in some cases, lower taxes.



The 2020 August Job Report



- The unemployment rate dropped to 8.4 percent in August, the Labor Department reported on Friday, September 4, 2020, marking the fourth month of declines even as the pace of job growth is slowing.
- The August rate is down from its April peak of 14.7 percent, but still remains far above the 3.5 percent recorded in February, before coronavirus shutdowns took hold.



CES Highlights

Construction





Construction employment changed little in August (+16,000). Construction of buildings added 13,000 jobs and residential specialty trade contractors added 25,000, offsetting a decline of 16,000 in nonresidential specialty trade contractors. Employment in construction was 425,000 lower than its February peak.

Construction spending, building permits, and new homes sold in July and lower mortgage rates in August point toward strength in construction, although heavy precipitation in the eastern half of the United States may have hindered job growth in August.

- ASA sent a letter to congressional leadership requesting the expansion of "second draw" Paycheck Protection Program (PPP) loans for small businesses. The current draft of the next round of recovery legislation would require that small businesses applying for a second PPP loan to have suffered a 50 percent decline in revenue. Our letter requests that the 50 percent requirement be lowered so that additional small businesses that were adversely impacted by the pandemic are eligible for a second PPP loan and loan forgiveness.
- ASA joined the Small Business Legislative Council (SBLC) in a letter to Congressional Leadership conveying business-focused proposals to be included in the latest COVID-19 relief package:
 - Establish carefully crafted liability shields for re-opening businesses
 - Expand the Paycheck Protection Program to allow small 501(c)(6) organizations to obtain PPP loans and provide automatic loan forgiveness for loans under a certain threshold
 - Restore the business deductions eliminated by the Tax Cuts and Jobs Act, including the deductibility
 of business meals, entertainment expenses and parking
 - Make permanent and expand the 199A deduction established by the Tax Cuts and Jobs Act by significantly increasing the threshold level and eliminating the limitations applicable to specialized service businesses
 - Provide tax incentives for small businesses to offset the cost of deep cleaning their facilities and providing PPE to their employees
 - Increase infrastructure funding
 - Eliminate the cap on the State and Local Tax (SALT) deduction in order to boost small businesses in the real estate, construction and mortgage banking areas that are located in the areas most affected by the cap
 - Exempt non-public businesses with below a certain number (such as 100) of shareholders, members or partners or with annual gross receipts below a certain threshold (such \$10,000,000 indexed) from Internal Revenue Code Section 409A
 - Simplify the 401(k) discrimination tests and make them easier to pass without having to adopt the safe harbor and eliminate the obsolete and complicated top heavy rules to make it easier for small businesses to administer their own plans and reduce fees to professional advisors
 - Relax the rules dealing with mortgage interest by allowing interest to be deducted over the \$750,000 mortgage balance and increase the mortgage limit from \$1 million to \$1.5 million

- ASA sent a letter to congressional leadership expressing strong support of the bipartisan Small Business Expense Protection Act (S. 3612/H.R. 6821), which would ensure that small businesses can deduct eligible expenses paid with a forgiven Paycheck Protection Program (PPP) loan from their taxes.
- ASA sent an opposition letter to Congress about IRS's PPP latest notice clarifying that any business expenses, which are normally tax deductible, but which are forgiven as part of a PPP loan become non-deductible.
- ASA sent a letter to President Trump to extend the Paycheck Protection Program (PPP).
- ASA sent a letter to the President Trump requesting increased federal infrastructure funding.
- ASA sent a letter to the Attorney General recommending the Department of Justice temporarily suspend operations by the Federal Prison Industries.
- ASA sent letter seeking OSHA guidance on the reportability of COVID-19 cases and recommending an approach to social distancing and face coverings in construction.
- ASA sent a letter urging Congress to allocate additional funds to the PPP program and EIDL Program along with extending eligibility to 501©6 organizations.
- ASA sent a letter to Congressional Leadership on the need for emergency action regarding the acceptance of electronic bonds.
- ASA sent a letter encouraging the issuance of exemptions for operations and maintenance of essential infrastructure during COVID-19.
- ASA issued a Gubernatorial Statement on keeping the construction industry an essential service.

 ASA, along with the Transportation Construction Coalition (TCC), launched an advertising and grassroots campaign designed to encourage Congress to make new infrastructure investments as the major catalyst for economic recovery in the wake of COVID-19.

Amicus Brief

- On June 11, 2020, the Washington, D.C. Circuit Court denied the AFL-CIO's OSHA petition and determined "OSHA's decision not to issue an ETS is entitled to considerable deference." The court further found that, *"in light of the unprecedented nature of the COVID-19 pandemic, as well as the regulatory tools that the OSHA has at its disposal to ensure that employers are maintaining hazard-free work environments, OSHA reasonably determined that an ETS is not necessary at this time."*
 - On May 30, 2020, ASA filed an amicus brief in opposition to the AFLCIO's Petition compelling OSHA to issue an emergency temporary standard for infectious diseases ("ETS"), to protect employees from COVID-19.

2019 Legislative Accomplishments

- **S. 1434:** Banning reverse auction in construction services unanimously passed in the Senate 100-0.
- **Cadillac Tax:** President Trump signed the law for the full repeal of the 40% excise tax on high-cost health plans (the "Cadillac Tax").
- 529 Apprenticeship Savings Accounts: Setting Every Community Up for Retirement Enhancement (SECURE Act), which takes effect on January 1, 2020:
 - <u>expands 529 education savings accounts to</u> <u>cover registered apprenticeships;</u> homeschooling; up to \$10,000 of qualified student loan repayments (including for siblings); and private elementary, secondary, or religious schools.




On Thursday, August 20, 2020, Congressman Mo Brooks (R-AL) toured Claborn Manufacturing's new, state of the art facility located in Tanner, AL. The tour was led by former ASA President, Kerrick Whisenant, President of Limestone Building Group, the constructor of South Limestone Industrial Park where the plant is located. Claborn Manufacturing's sister company and ASA member, Cornerstone Detention Products, installs products in prisons and jails including doors, frames, windows, and furniture, which are now being made at this new Claborn facility utilizing high-end, technologically driven, robotic manufacturing processes.

Claborn's expansion to a 150,000 square-foot facility brought 50 new highly skilled and good-paying jobs to Rep. Brooks' district. Rep. Brooks is a member of the House Armed Services Committee which has jurisdiction over many ASA legislative priorities including the National Defense Authorization Act (NDAA). On July 2, 2020, Rep. Brooks supported ASA with his vote to include H.R. 2344, the Small Business Payment Performance Act, as an amendment to the Fiscal Year (FY) 2021 National Defense Authorization Bill.

Regulatory Update – Payment Bond Thresholds

- Federal Acquisition Regulation (FAR) Payment Bond Increases
- On August 31, 2020, ASA, along with the Construction Industry Procurement Coalition (CIPC), submitted comments against the increase of payment bond threshold from \$35, 000.00 to \$40,000.00. Initially, we were asked by the surety folks to lead this effort against the Federal Acquisition Regulation (FAR)'s payment bond increases; however, we strategically decided that it would be best to lead this effort under the CIPC umbrella.

Regulatory Update

- ASA is a member of the Construction Industry Safety Coalition (CISC)
- Reporting Rule: The Occupational Safety and Health Administration has dropped a requirement that employers with at least 250 workers must electronically submit annual injury and illness reports.
- Joint Employer: The Obama Administration Department of Labor found that most independent contractors were actually employees, making the company responsible. That guidance has been rescinded, putting the burden back on the individual.
- **Beryllium:** New OSHA standards to protect workers from cancer and chronic beryllium disease are now partially under review for the construction and maritime industries. The levels are not under review, but related activities are, such as medical monitoring and workplace exposure measurements.
- **Silica:** OSHA submitted a proposal to revise its silica rule's list of acceptable practices for limiting workers' exposure to the dust.







Ask your Legislators to Support HB 271/ SB 324

ASA Tennessee needs your help to educate your state legislators on the importance of House Bill 271/ Senate Bill 324, legislation that would ensure you are paid for the work you do while also allowing you the ability to suspend work should a general contractor fail to abide by the contract. Specifically, HB 271/SB 324 would:

- ban pay-if-paid clauses in contracts;
- gives subcontractors lien rights equal to that of general contractors;
- speeds up the process for contractor and subcontractors to get retainage; and
- allows general contractors and subcontractors the ability to stop work.

As a subcontractor, HB 271/SB 324 would protect your small business and employees from going unpaid by providing the necessary tools to guarantee project owners and general contractors are held to their contractual commitments.
