3. Neither ASA nor the judges will contact applicants to obtain additional information.

## Recognition

1. ASA will acknowledge receipt of each entry no later than Jan. 4, 2020.
2. ASA will notify all nominees of the winner of the 2019 awards no later than Jan. 31, 2020.
3. ASA will present the 2019 awards in conjunction with ASA SubExcel 2020, which will be held March 4-7, 2020 in Las Vegas.

## Criteria for Evaluation

Evaluation of entries will be conducted by a by a working group of members of the ASA Government Relations Committee. Neither applicants nor nominees need to be affiliated with ASA. Judges will consider each of the following factors when assessing the entry:

- Importance of the issue/objective to the interests of construction subcontractors, specialty trade contractors and suppliers.
- Use of analytical skills to develop and implement a plan to pursue a successful outcome.
- Effort and success in developing support for the issue/objective within and outside of the construction industry.
- Degree of opposition to the issue/objective within and outside of the construction industry.
- Cost effective use of resources, including dollars and time.
- Demonstrable success with the government advocacy or campaign.
- Quality of the presentation.
